This year Council introduced smaller more frequent bus trips which resulted in greater social connections between participants and Council staff.</li> <li>Council secured a grant for over \$300,000 for the development of a 'Challenger Obstacle Course', a fitness structure that aims to increase youth participation and decrease anti-social behaviour. Consultation was undertaken with young people and children around the design, layout and equipment to be installed to ensure the structure meets the needs of our community. The obstacle course will be developed in Grant Park in 2020 and will be accessible to all community members free of charge.</li> <li>Council also continued to deliver the 'Stay Standing' and 'Stay Active' falls prevention programs for seniors from August – September 2019.</li> <li>Active and passive recreational activities are key to creating liveable urban environments and helps to achieve a more active, engaged and healthy community.</li> </ul>

Council employed these methods to promote its Community events and services. Council increased the frequency of its residents newsletters, to five per calendar year, understanding that for many in the community mailed
				information was still the preferred method of communication. Traditional and digital engagement methods were used to ensure the community had a say in future planning, such as the consultation on a modern library and community space.

This campaign educated children and the wider community on how to stay safe in public places and the impact of littering on the community. To further support the campaign, a comic book was developed featuring the superhero characters Super Safe Sally and Captain Clean Up. In partnership with local services and the Burwood Police Area Command, Council held a series of empowerment workshops for women who have experienced domestic violence. These workshops created opportunities for information sharing and social connections and built participants personal safety, online safety awareness and knowledge of financial planning. Council continued to disseminate the Household Safety Booklet to local residents. The booklet equips residents with personal and household safety tips, key contacts and information on illegal dumping. Feeling safe in your home and local community is an important part of everyone's health and well-being. Council's programs continue to target crime and safety issues and raise community awareness, making our community safer, more sustainable and resilient.

The workshop resulted in increased knowledge among both Police and Council staff in CPTED principals as well as a greater understanding of each other's roles and contribution to the Development Application process. These actions are helping Council create a safer public environment for
