

(ITEM 93/20) CONTRACT BETWEEN BURWOOD COUNCIL AND VISY RECYCLING - DETERMINATION OF DISCREPANCY OR INCONSISTENCY IN CONTRACT

That the Council resolve to make a determination for the purpose of the Contract of Supply between Burwood Council and Visy Paper Pty Ltd atf The Southern Converters Trust dated October 2013 (the Contract) as follows:

- (a) Pursuant to clause 1.3.3 of the Contract, the discrepancy or inconsistency in the words "... at least that period stated in the Annexure..." in the second sentence of clause 2.2.3 of the Contract and the Annexure, is resolved by Council determining that those words are referring to the period for which the Contract may be extended in the Annexure to the Contract; and
- (b) Pursuant to clause 1.3.3 of the Contract, the discrepancy or inconsistency between clause 2.2.3 and the words "The period prior to expiration of the initial Contract Term by which notice of extension must be given: Three months" in the Annexure, is resolved by Council determining that clause 2.2.3 has precedence or priority over those words in the Annexure, so that notice of Council's intention to extend the operation of the Contract is to be given at any time prior to the expiration of the Initial Contract Term ie. by 30 September 2020.
