#### <u>Summary</u>

This report provides an update on the Food Organics Garden Organics (FOGO) Trial extension.

The FOGO trial extension, with the change to the frequency of the waste collection service formally commenced on Wednesday 13 September 2023 with collection of the green lid FOGO bin and the red lid bin. From this date, the red lid bin has been collected fortnightly.

In the period 13 September 2023 to 22 November 2023 65.48 tonnes of FOGO material has been collected from 3,651 x 240L green lid FOGO bins. This equates to eight (8) waste collection trucks.

## (ITEM NM4/23) NSW GOVERNMENT'S VISION WILL HAVE MAJOR IMPACT ON CROYDON, THE MALVERN HILL ESTATE AND SURROUNDS

## <u>Summary</u>

The Premier, Chris Minns and the Minister for Planning and Public Spaces, Paul Scully on Thursday 7 December 2023 issued a media release titled *A Shared Responsibility: The plan to begin addressing the housing crisis in NSW.* 

The media release identified a program to accelerate the delivery of housing across Greater Sydney, titled the Transport Orientated Development Program. No consultation was undertaken with Councils as part of the development of this program and the announcement has come as a surprise to many councils

The Program includes two (2) tiers: Tier One – Accelerated Precincts and Tier Two – Rezonings:

- Tier One Accelerated Precincts identifies eight Sydney transport hubs for accelerated rezoning for the delivery of up to 47,800 new, well located, high and mid-rise homes over the next 15 years. No precincts within the Burwood LGA have been identified.
- Tier Two Rezonings, however is proposing to snap rezone 31 locations across NSW, within 400m of Metro or suburban rail stations to make 3-6 storey residential flat building permissible in all residential zonings. Croydon is one of these locations that has been announced.

To implement the identified changes to the planning system, the NSW Government has announced it will apply a State Environmental Planning Policy or SEPP.

SEPPs under the Environmental Planning and Assessment Act 1979, override and can switch off provisions under any subordinate Local Planning provisions such as Local Environment Plans or Development Control Plan.

In applying the new SEPPs, the announcements have indicated that new sets of planning controls would be formulated. NSW Government has also flagged that the creation and implementation of these new planning controls would not be prevented by the existence of existing local environmental or heritage conservation area provisions. The existing controls are likely to still apply, but only to the extent they are not inconsistent with the new state planning provisions.

This is extremely disappointing and I am not only shocked at the lack of regard for the preservation of beautiful conservation areas like the Malvern Hill Estate in Croydon, but I am outraged at the lack of consultation with Councils and the communities we serve.

There has been no consultation with Council or Council planning staff over the release of this new State Policy, nor has there been an opportunity for our community to provide feedback on the proposed planning changes which have the potential to significantly impact on our local community.

I am extremely concerned with the impacts of State planning policies being developed in isolation, or without due regard, to each other, and without consideration to the aggregated impact that this has on the amenity of residents and the character of neighbourhoods and the streetscape, something the residents of Croydon and Burwood highly value.

I am especially concerned that the proposed changes also undermine Council's strategic planning by promoting additional densities that are contrary to our current planning framework, including our heritage and neighbourhood character and provisions in our Local Environmental Plans.

The lack of proper consideration and planning, in collaboration with Council which then increases pressure on the provision of existing services and the capacity for council to provide adequate and appropriate infrastructure to meet the needs of our rapidly growing communities, as well as undermining local planning and resulting in the degradation of the existing character of our neighbourhoods.

Burwood Council has long been an advocate for the delivery of planning frameworks that create the capacity for future housing delivery – our draft Masterplan for the Burwood North Precinct is a recent example of this and proposes to create the capacity for an additional 5,300 dwellings over the next 20-30 years. This is where housing delivery in Burwood needs to be focused, not in Croydon.

On 19 December 2023, the General Manager and Council Planners will be meeting with the Minister for Planning and Public Spaces, the Hon. Paul Scully to further discuss this unsubstantiated proposal to accelerate rezonings and significantly alter the character of Croydon.

  - a) Voicing disappointment and concern over the proposal to snap rezone Croydon to allow residential flat building development built forms with no regard for the heritage and streetscape character values of the neighbourhood.
  - b) Request the immediate release of any available evidence based planning and rationale that informed the announcement of Croydon as a precinct to be rezoned
  - c) Request that any community consultation which proposes major changes to the planning framework that have the potential to impact a significant number of residents and adversely impact on the highly valued heritage character be appropriately undertaken from February 2024 outside the Christmas and new year holiday period.
  - d) Request that the proposal to snap rezone Croydon be held in abeyance or rescinded, to allow Burwood Council to continue its long standing vision for future planning and increased densities to be centred in and around the Burwood Town Centre and the new Metro Railway Station.
  - e) Request that the Department of Planning and Environment actively communicate and engage with Council with appropriate modelling and technical studies being completed prior to the establishment of any new planning controls in Croydon which could result in irreversible impacts on the heritage and streetscape character values of the neighbourhood.
- 2. Council (via the General Manager), as a matter of urgency, write to all ratepayers in the area affected by the Tier 2 proposal to inform them of the announcement and Council's lack of involvement in the decision making process.
- 3. Council to run an online community petition against the government proposal, and incorporate results as required in any future submissions to the NSW Government on this matter.
